# 2023-2027 General Class Question Pool Errata Issued February 1, 2023 becomes effective July 1, 2023

If you are a Tech and want to go for your General there are a new set of questions from the first of the year, or rather a set of questions altered some from the last set. The new revised set of questions became the new pool as of July 1, 2023. There is probably a good chance if you knew and understood the previous set you could take the test and pass this one.

I would like to be able to give you a list of the changes but for the best of me, I couldn't find a good list of all the changes.

Opinion: Why should you get your General? This is the door to most everything in HAM radio now. You get a lot more band width privileges where you can work. HAM radio has moods and areas that are hot to work. Once it was CW. By the 1950s SSB became the area to work. Then came some digital modes PSK31, Packet, RTTY and more. Now its FT4 and FT8 that is hot. The bottom line is a General license gives you tons of new privileges to work your HAM radio.

## Should I go on and get an Extra?

You get a little more band width privileges, but the General is the most important second step.

This is what the ARRL had to say about the new question set:

The National Conference of Volunteer Examiner Coordinators' (NCVEC) Question Pool Committee (QPC) has released the 2023 - 2027 General Class FCC Element 3 Syllabus and Question Pool to the public. The new General Question Pool is effective July 1, 2023, through June 30, 2027.

The new pool incorporates some significant changes compared to the 2019 - 2023 version. Its 432 questions were modified slightly to improve wording and to replace distractors; 51 new questions were generated, and 73 questions were eliminated. This resulted in a reduction of 22 questions, bringing the total number of questions in the pool down from 454. The level of difficulty of questions is more balanced, and the techniques and practices addressed have been updated.

The pool questions are available from the ARRL at no cost as a Microsoft Word document and PDF document. The single graphic required for the new General Question Pool is available from the ARRL within the documents, or separately as PDF and JPG file formats.

Study only the right answers, don't wast your time with the wrong ones.

# Up Date on the promotion of FT8 and FT4 from the April News Letter

Band conditions are really bad this summer but this is what FT4 & FT8 modes are made. In the past using SSB I had made some international and US contacts but not a lot. Using these new digital modes are a lot like making contest QSOs, short and sweet but this time using a computer when the other person acknowledges you.

Since around February this year, I have made 620 contacts and 40 different countries. It is blowing my hat off. For a good operator working one of these two digital modes, it would be around 1000 or more contacts.

Most acknowledgements and logging is done in the program, but this information on your computor needs to be sent to a third party logging software. In some contacts they don't use a recognized acknowledgement loggings program over the internet to a recognized logging software site and as an alturnative they may even ask for cards. The custom is that you will pay both ways including the return postage for their card. With paying for a card to hang on your wall for maybe at least 100 cards or more a year at around \$3 or \$4 dollars per card for a HAM this is starting to get expensive. My experience is that I get around two thirds logging acknowledgements on an offsite software program, the rest won't acknowledge.

Trying to figure out the logging software can be as much fun as trying to figuring how to set up your computer and your radio where they can talk to each other.

I set up two logging programs, QRZ and ARRL – LoTW. The file that you log with is the ADI file generated by the program software under Logbook. When I am ready to log my contacts, I copy the ADI file and put it in a special folder I set up under Documents named ADI. In QRZ I just load the ADI file into my log book on QRZ. In LoTW I authenticate it then load it into the program.

You have to sign up for LoTW and they send you a password to activate the program. When you open the program there are four boxes. The top box authenticates it and the bottom box loads it into the program.

There are all kinds of ways to load your contacts into the log books and load it back and forth but they were smarter than me. Getting my Extra Ticket was easier.

On FT8 and FT4, if you have speaking challenges, you can't hear well, have challenges using you hands, stuck in bed, baby have I got the part of HAM radio made for you to communicate around the country and around the world and have a load of fun.
